1. 入學時間

Fall class: 1st semester of the 2026 academic year (September 2026); the actual start date of the academic term will be subject to CGUST's calendar announcement.

2. 修業年限

Period of study

碩士班：以1至4年為限。

Master's programs: One (1) to four (4) years.

二、申請資格/ II .Application Requirements

申請資格悉依據教育部《[外國學生來臺就學辦法](#)》所規定辦理，辦法如經修正，將以教育部公告為準。

Application eligibility shall follow the provisions on the Ministry of Education's [Regulations Regarding International Students Undertaking Studies in Taiwan](#). If these Regulations are amended, the announcement of the Ministry of Education shall prevail.

1. 國籍規定

Nationality regulations

依據外國學生來臺就學辦法，你必須符合下列其一身份，方可以外國學生身分申請本校：

According to the Regulations Regarding International Students Undertaking Studies in Taiwan, you must meet one of the following criteria to apply to CGUST as an international student:

1.1. 具外國國籍且未曾具有中華民國國籍，且符合下列規定：

A person of foreign nationality who has never held Republic of China ("R.O.C.") nationality and who meets the following criteria:

1.1.1. 未曾以僑生身分在臺就學。

The person has never undertaken studies in Taiwan as an overseas compatriot student.

1.1.2. 未於申請入學當學年度依僑生回國就學及輔導辦法經海外聯合招生委員會分發。

The person has not been given a placement in the current academic year by the University Entrance Committee for Overseas Compatriot Students in accordance with the Regulations Regarding Study and Counseling Assistance for Overseas Compatriot Students in Taiwan.

1.2. 具外國國籍且符合下列規定，且最近連續居留海外六年以上者。

A person of foreign nationality who meets the following criteria and who in the immediate past has resided overseas continuously for at least six (6) years.

1.2.1. 申請時兼具中華民國國籍者，應自始未曾在臺設有戶籍。

A person who at the time of their application also holds dual R.O.C. nationality shall have never had household registration in Taiwan.

- 1.2.2. 申請前曾兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時已滿八年。

A person who before the time of their application also held dual R.O.C. nationality but no longer does at the time of their application shall have renounced their R.O.C. nationality with the approval of the Ministry of the Interior on a date at least eight (8) full years before making their application.

- 1.2.3. 前二款均未曾以僑生身分在臺就學，且未於當學年度接受海外聯合招生委員會分發。

The person referred to in either of the preceding two subparagraphs has never undertaken studies in Taiwan as an overseas compatriot student and has not been given a placement in the current academic year by the University Entrance Committee for Overseas Compatriot Students.

- 1.3. 依教育合作協議，由外國政府、機構或學校遴薦來臺就學之外國國民，其自始未曾在臺設有戶籍者，經教育部核准，得不受前二項規定限制。

A foreign national who has been selected by a foreign government, organization, or educational institution to study in Taiwan in accordance with an education cooperation agreement, and who has never had household registration in Taiwan may be given exemption from the restrictions set out in the two preceding paragraphs if the Ministry of Education gives approval.

- 1.4. 具外國國籍並兼具中華民國國籍，且於外國學生來臺就學辦法中華民國一百年二月一日修正施行前已提出申請喪失中華民國國籍者，得依原規定申請入學，不受第二項規定之限制。

A person who held both foreign nationality and R.O.C. nationality and applied for annulment of their R.O.C. nationality before the date of effect of the February 1, 2011 amendment to the Regulations Regarding International Students Undertaking Studies in Taiwan may apply for admission as an international student in accordance with the provisions in place before the amendment and is not subject to the restrictions set out in Paragraph 2.

- 1.5. 具外國國籍，兼具香港或澳門永久居留資格，且未曾在臺設有戶籍，申請時於香港、澳門或海外連續居留滿六年以上者，得依本規定申請入學。

An applicant of foreign nationality, who is eligible for permanent residence in Hong Kong or Macao, who has never had household registration in Taiwan, and who at the time of their application has resided in Hong Kong, Macao, or elsewhere overseas continuously for at least six (6) years may apply for admission in accordance with the provisions of these Regulations.

- 1.6. 曾為大陸地區人民具外國國籍且未曾在臺設有戶籍，申請時已連續居留海外六年以上者，得依本規定申請入學。

A person who was formerly from the Mainland Area and who has foreign nationality and has never had household registration in Taiwan, and who at the time of their application has resided overseas continuously for at least six (6) years may apply for admission in accordance with the provisions of these Regulations.

- 1.7. 上述所稱海外，指大陸地區、香港及澳門以外之國家或地區；所稱連續居留，指外國學生每歷年在國內停留期間不得逾120日。連續居留海外採計期間之起迄年度非屬完整曆年者，以各該年度之採計期間內在國內停留期間未逾120日予以認定。

The term "overseas" mentioned above refers to countries or regions other than the Mainland Area, Hong Kong, and Macau; the term "reside overseas continuously" means that an international student has stayed in Taiwan for no more than a total of 120 days in each calendar year. When

calculating the number of consecutive years spent overseas, if the initial or final year of the period is not a complete calendar year, any time spent in Taiwan in the initial or final year must not exceed 120 days.

但符合下列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入海外居留期間計算：

However, this restriction does not apply if a person can present documentary proof of any of the following circumstances, in which the time that they spent in Taiwan is not counted towards the period of continuous residence overseas:

1.7.1. 就讀僑務主管機關舉辦之海外青年技術訓練班或教育部認定之技術訓練專班。

attended an overseas youth training course organized by the Overseas Compatriot Affairs Council or a technical professional training program accredited by the Ministry of Education;

1.7.2. 就讀教育部核准得招收外國學生之各大專校院華語文中心，合計未滿二年。

spent a total period of less than two (2) years undertaking Mandarin language classes at a Mandarin language center at a university or tertiary college which has Ministry of Education approval to recruit students overseas;

1.7.3. 交換學生，其交換期間合計未滿二年。

spent a total period of less than two (2) years in Taiwan as an exchange student; or

1.7.4. 經中央目的事業主管機關許可來臺實習，實習期間合計未滿二年。

spent a total period of less than two (2) years undertaking an internship which they came to Taiwan to undertake with the approval of the designated central competent authority;

1.7.5. 具有國籍法第二條規定情形者，為本辦法所定具有中華民國國籍。

In these Regulations a person to whom any of the circumstances set out in Article 2 of the Nationality Act apply is deemed to have R.O.C. nationality.

1.8. 上述所定六年、八年，以擬入學當學期起始日期（八月一日）為終日計算之。

The periods of six (6) years and eight (8) years referred to above shall be calculated using the starting date of the semester (August 1) as the end date of the period.

2. 學歷資格

Academic qualifications

2.1. 具學士學位者，得申請入學本校碩士班。

A student with a bachelor's degree may apply for admission to a master's program in CGUST.

2.2. 須符合教育部採認規定之高中、大學或獨立學院畢業（[教育部外國大學參考名冊](#)），畢（肄）業學校應為已列入參考名冊者；未列入參考名冊者，應為當地國政府學校權責機關或其認定之教育專業評鑑團體所認可。

Must have graduated from a high school, university, or independent college that meets the Ministry of Education's recognition criteria ([Ministry of Education's Database for the Reference List of Foreign Universities](#)). The school of graduation (or dropout) should already be on the reference list; Educational institutions that are not included in the reference list must be accredited by the local government's supervisory authority for schools or a professional

accreditation institution recognized by such authority.

- 2.3. 具有教育部《入學大學同等學力認定標準》有關該學制同等學力報考資格者。

Those who possess the equivalent academic qualifications for university admission to apply for the respective academic system as stipulated in the Ministry of Education's Standards for Recognition of Equivalent Educational Levels for University Admission.

- 2.4. 持大陸地區學歷：應依《大陸地區學歷採認辦法》規定辦理。

Academic credentials from Mainland China: shall be handled in accordance with the Regulations Regarding the Assessment and Recognition of Academic Credentials for Mainland Area.

- 2.5. 持香港或澳門學歷：應依《香港澳門學歷檢覈及採認辦法》規定辦理。

Academic credentials from Hong Kong or Macao: shall be handled in accordance with the Regulations Governing the Examination and Recognition of Educational Records from Hong Kong and Macao.

- 2.6. 前二項以外之國外地區學歷，應依《大學辦理國外學歷採認辦法》規定辦理。

Academic credentials from overseas other than those referred to the preceding two items shall be handled in accordance with the Regulations Governing the Assessment and Recognition of Foreign Academic Records by Institutions of Higher Education.

- 2.7. 外國學生申請來臺就學，以一次為限。但下列情形，不在此限：

An international student applying to study in Taiwan may only apply once. However, this does not apply under the any of the following circumstances:

- 2.7.1. 於完成申請就學學校學程後，申請碩士班以上學程，逕依本校規定辦理。

After completing the program applied for at CGUST, applications for admission to a master's program or higher shall be handled by CGUST in accordance with its regulations.

- 2.7.2. 外國學生申請來臺就讀學士班學程，在國內停留未滿一年，因故退學或喪失學籍，得重新申請來臺就學，並以一次為限。

Foreign students who for some reason, apply to study undergraduate programs in Taiwan and withdraw from their studies or lose their student status before residing a full year in Taiwan may reapply to study in Taiwan, but only once.

- 2.8. 曾因學校操行、學業成績不及格或因犯刑事案件經判刑確定致遭退學者，則不得申請入學。

However, those who have been expelled as a result of unsatisfactory conduct, poor academic performance, or due to a criminal conviction are not permitted to apply.
